New year's message from the General Secretary

At the risk of repeating what our President mentioned on the very difficult and challenging year that we just closed, Apimondia was confronted with the crucial task of adapting some of its working arrangements to take stock of the undeniable changes produced by the Covid-19 pandemic.

In order to stay alive and still interact with the members despite the constraints posed by the strict limitations to travel and meetings, the Executive Council took the unprecedented step of staging its annual meeting in a virtual format and actually it went beyond. In fact, while the Council only meets once a year over a weekend, last year a number of virtual meetings were held on Zoom to the tune of almost once every month.

In addition to this, the Apimondia Regional Commissions urged the organisation of other virtual meetings to bring together the members and other stakeholder from the same region and exchange view and experience in this difficult period.

Last December also an Apimondia Open House virtual meeting was held in order to keep in touch with the members and let them know that Apimondia is still alive and kicking and carrying on with its work.

A number of colleagues were also invited to join virtual meetings staged by other organisations to provide Apimondia's inputs and vision on honey fraud, quality standards and the impact of Covid-19 on the honey market.

Further below in this Newsletter you will see the range and number of initiatives undertaken by Apimondia in 2020 and more are to come.

As you are aware at present the offer of meetings can only be in virtual format, but Apimondia is planning to implement hybrid events as soon as possible, including the congress in Russia next year to ensure more beekeepers and stakeholders can attend the event and benefit from it.

Another important initiative that Apimondia put in place is the issuance of two vacancy announcements to fill the positions of scientific communication specialist and media specialist to assist our work to disseminate quality and timely information on Apimondia's activities. The deadline for sending applications is Sunday 24 January 2021.

Apimondia strongly wants to be closer to its members and also provide them with more and more up-to-date information to assist them in their daily work.

Update on important activities and achievements in 2020

January 2020 - Apimondia Statement on Honey Fraud

In January 2020, Apimondia published the reviewed version of the Statement on Honey Fraud as the official position of Apimondia regarding honey purity and authenticity, fair standards of production and the best available recommended methods to detect and prevent honey fraud.



This Statement aims to be a trusted source for authorities, traders, retailers, manufacturers, supermarkets, consumers and other stakeholders of the honey trade chain to ensure they stay up-dated with the current concepts

and new testing developments regarding honey purity and authenticity. It is also a guide to promote best practices for the prevention of honey fraud and all of its insidious negative side effects on bees, beekeepers, crop pollination and food security.

February 2020 - International Meliponini Conference and Asian Apicultural Association (AAA) Philippines Symposium on Pollinator Conservation

The International Meliponini Conference and Asian Apicultural Association (AAA) Philippines Symposium on Pollinator Conservation provided a forum for bee researchers, policy makers, farmers, students and beekeepers from around the world to discuss topics related to bees and pollination, and share their beekeeping practices and experiences.

Held at the University of the Philippines Los Baños (UPLB) on 25-28 February 2020, the event was jointly organised by the UPLB through its Bee Programme, the Department of Agriculture - Bureau of Agricultural Research and the AAA Philippines. The participants were from Malaysia, Indonesia, Japan, Australia, United States of America, Italy, Cambodia, Germany, Sri Lanka, United Kingdom, Venezuela and Vietnam. The scientific session was complemented with a workshop on stingless bees, a round table discussion, a Grand Honey Festival and Api-Expo.

The resolutions of the conference were crafted as follows: forging collaboration on pollination research, inclusion of the use of isotope techniques in testing for honey adulteration and establishing standards for stingless bee honey. Apimondia was represented by Mr. Riccardo Jannoni-Sebastianini who gave a talk on the World Bee Day and the importance of pollinators in the ecosystem.

March 2020 - Pesticide residues in agricultural imports must not compromise public health and the European Green Deal



Forty-six International and European organisations combined their voices and wrote a letter addressed to Ms. Stella Kyriakides, European Commission, with the title “Pesticide residues in agricultural imports must not compromise public health and the European Green Deal”.

The letter was an attempt to highlight that a possible consideration by the European Commission to accept residues of certain

pesticides that are banned for use in the EU on imported products, would defeat the European Green Deal and the Commission’s stated ambition to reduce the EU’s dependency on pesticides. Moreover, failure of addressing effectively this issue could bring EU farmers to a state of an unfair competition from abroad.

The coalition urged the Commission to fully implement the necessary legal provisions, without any exceptions.

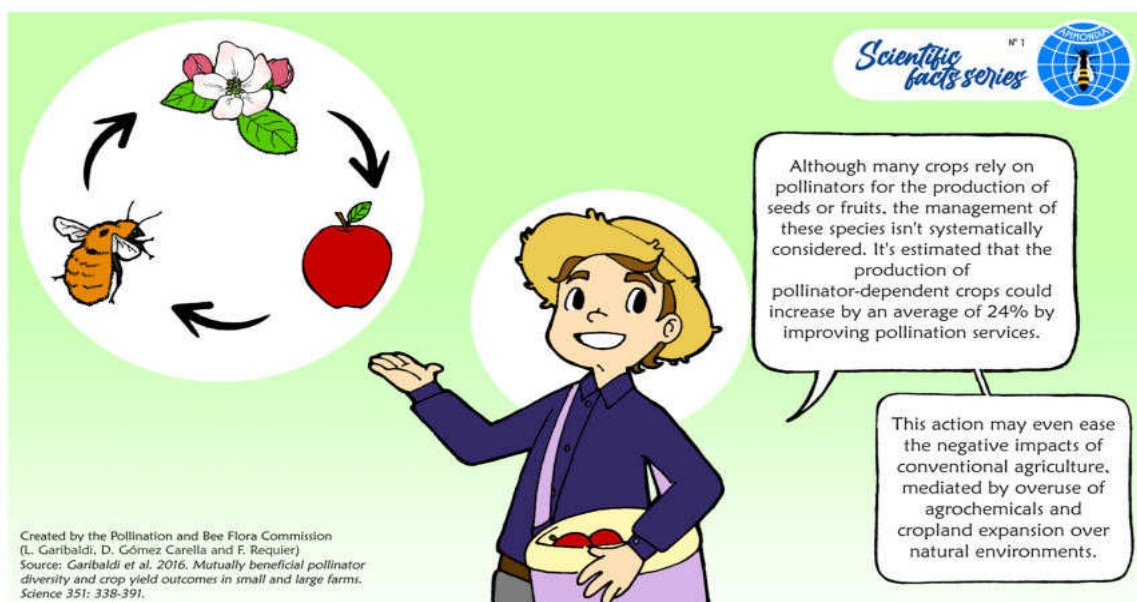

July 2020 - Evaluation of the direct economic impact of decreasing prices of honey on the main honey export countries of the Americas

A comprehensive and detailed report was prepared by the Apimondia Regional Commission for the Americas and the Apimondia Scientific Commission on Beekeeping Economy that was published on the Apimondia’s website:

July-August 2020 - The first of the Scientific Basic Messages, prepared by the Scientific Commission on Pollination and Bee Flora, was published on the Apimondia’s website.



August 2020 - Apimondia Press release “Is Europe lowering the standards of Protection Goals for Risk Assessment of Pesticides to bees?”



A press release was published by Apimondia in line with the opinion of other world organisations on the protection goals and the standards during risk assessment of pesticides for bees, ought to be taken by the European Commission.

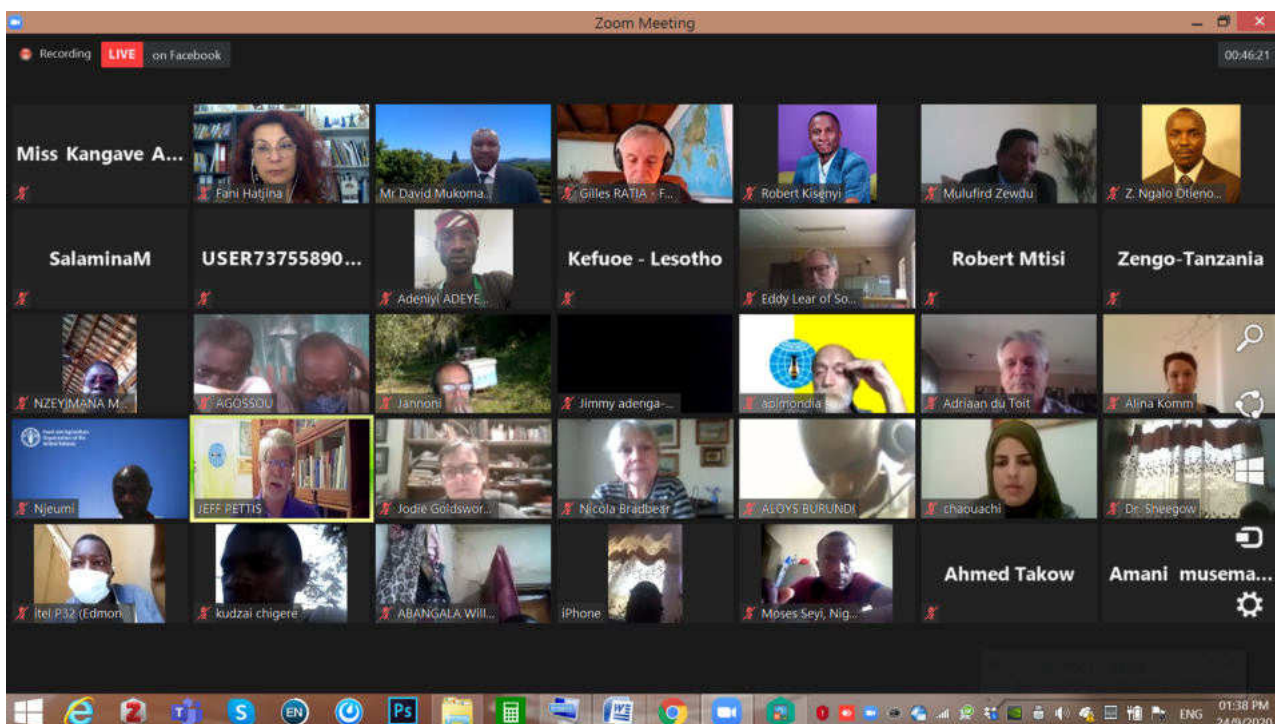
Among others, Apimondia stated: *It has been almost 8 years of continuous efforts to establish the protection goals for risk assessment and the levels to be accepted by the European Parliament and member states. EFSA's BGD of 2013 is the only*

comprehensive and up-to-date manual that uses a scientific method to describes how to assess the impact of pesticides on all pollinators. This document was never adopted by the member states, unfortunately, and never implemented due to high pressure from the Pharmaceutical Industry. However, we welcomed the European Parliament's rejection of the European Commission's draft proposal to 'compromise' to lower protection goals (only for acute toxicity and only for honey bees) on Wednesday 23rd October 2019. European citizens and beekeepers in Europe and around the world believed that with this decision the European Parliament confirmed the will to achieve higher levels of protection standards for bees, other pollinators and environment.

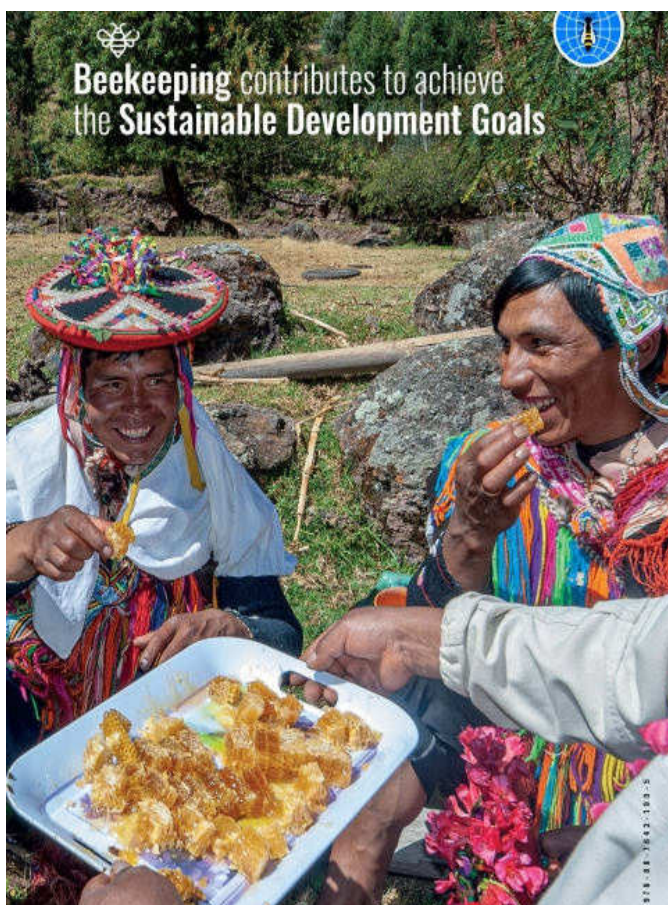

October 2020 - Booklet “Beekeeping contributes to achieve the Sustainable Development Goals”



This publication stems from the realisation that beekeeping holds an incredibly valuable potential in development work.

At present a commonly shared and recognised benchmark for the implementation and harmonised application of measures that assist interventions for development programmes is enshrined in the United Nations Sustainable Development Goals (SDGs).

These goals have been projected to unfold their beneficial effects over the 2015 - 2030 timespan so there is still a decade to support and see their implementation and further impact.

For those operating in the apicultural sector, the contribution of beekeeping to development activities is quite evident, but in other contexts this may not emerge just as clearly.

To this end, Apimondia decided to produce a concise reference publication to highlight and contextualise how beekeeping and its many

declinations can contribute to the achievement of the United Nations Sustainable Development Goals

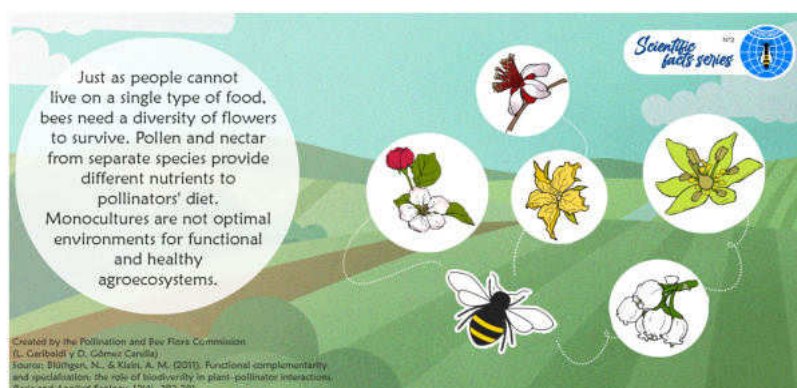

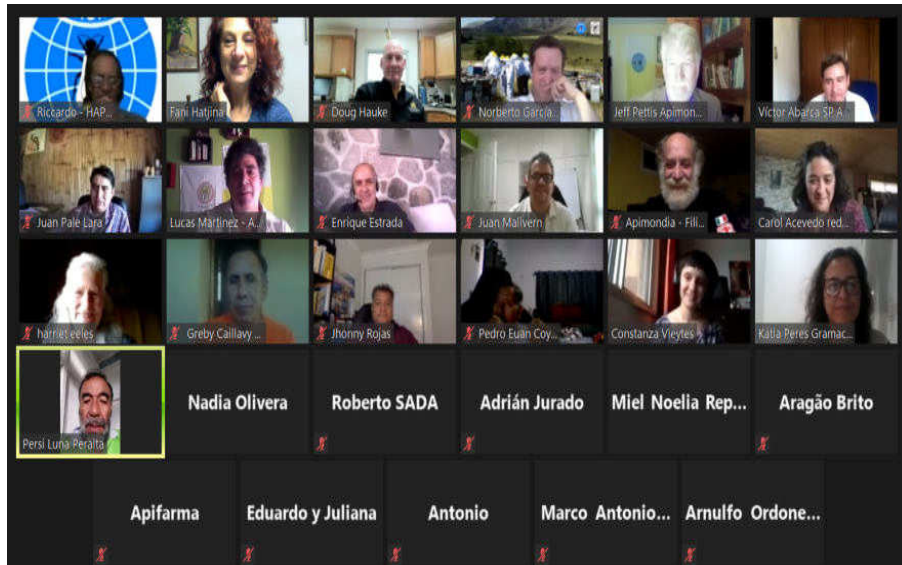
